

ASSIGNMENT OF MARKS

WHEREAS, AmSouth Bancorporation, a Delaware corporation having a mailing address of 1400 AmSouth-Sonat Tower, Birmingham, Alabama 35203, has transferred any rights that it may have in the marks shown on the attached Schedule A, for which the corresponding United States Trademark Registrations have been obtained, to Guaranty Federal Bank, F.S.B., a United States Federally Chartered Savings Bank having an address of 8333 Douglas Avenue, Dallas, Texas 75225, together with the goodwill associated with the above-referenced marks and the registrations of the marks, all pursuant to a Quitclaim Assignment of Marks with License Back, effective as of November 15, 2000 ("Quitclaim Assignment"); and

WHEREAS, the parties wish to evidence this transfer by an instrument suitable for public recordation, with the express understanding that the instant instrument is for purposes of public notice only and in no way modifies or revises any of the terms of assignment that are set forth in the Quitclaim Assignment; and

WHEREAS, such Quitclaim Assignment represents the final, complete and exclusive terms between the parties with regard to such assignment and the rights and liabilities of the parties;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, AmSouth Bancorporation hereby affirms that it has assigned to Guaranty Federal Bank, F.S.B., effective November 15, 2000, all right, title and interest in and to said marks, together with the goodwill of the business symbolized by the
