TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT dated as of February 5, 2004, by OMNI INTERNATIONAL, LLC, a Colorado limited liability company (the "Grantor") and WELLS FARGO BUSINESS CREDIT, INC., a Minnesota corporation (the "Secured Party").

WHEREAS, the Grantor and the Secured Party entered into a Trademark Security Agreement, dated as of February 6, 2002 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office at Reel 2457, Frame 0876 and Reel 2463, Frame 0553 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Credit Agreement (as defined in the Security Agreement);

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Trademark as herein provided:

NOW, THEREFORE, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Trademark, including without limitation the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Trademarks, effective as of the date set forth above.

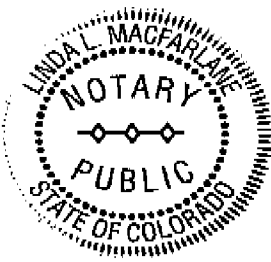
