ASSIGNMENT

WHEREAS, ASSIGNEE wishes to acquire all rights, title and interest in and to the Trademark; and

NOW, THEREFORE, in consideration of the above Recitals, which are incorporated herein by this reference, and for other goods and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. ASSIGNOR hereby assigns to ASSIGNEE all of its rights, title and interest in and to the Trademark.

2. This Assignment of Trademark may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
