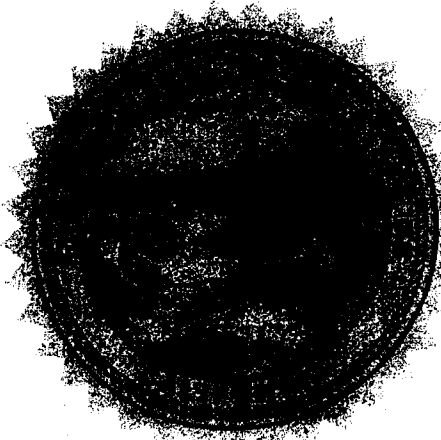

Aidan Foley and Lawrence A. Mondragon hereby certify that:

1. Aidan Foley is the duly elected and acting President of VRVS Global Corporation, a California corporation (the "Corporation") and Lawrence A. Mondragon is the duly elected and acting Secretary of the Corporation.

2. Article I of the Second Amended and Restated Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"I.

The name of this corporation is: AgoraeGlobal (the 'Corporation')."

3. The foregoing amendment has been duly approved by the Board of Directors of the Corporation.

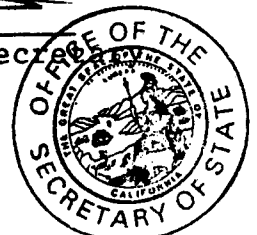
4. The foregoing amendment has been duly approved by the required vote of the shareholders of the Corporation in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of Common Stock of the Corporation is 24,837,132. The total number of outstanding shares of Series A-1 Preferred Stock of the Corporation is 10,897,864. The number of shares of Common Stock and Series A-1 Preferred Stock of the Corporation, voting together as a class, which voted in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent.
