



### **RELEASE OF LIEN IN TRADEMARKS**

**WHEREAS**, the Security Agreement was recorded in the United States Patent and Trademark Office on August 4, 2000 at Reel 2129/Frame 0016; and


**WHEREAS**, Assignee has satisfactorily performed all of its Obligations and Assignor desires to release its security interest in the Collateral.
