

### RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS is given as of this 15<sup>th</sup> day of March 2004 by Webster Business Credit Corporation, a New York Corporation, located at One State Street, New York, New York 10004, (as successor to IBJ Whitehall Business Credit Corporation) as Agent (as defined in the Security Agreement) (the "Assignor"), in favor of Sweetheart Cup Company, Inc., a Delaware corporation, located at 10100 Reisterstown Road, Owings Mills, Maryland 21117 (as successor in interest to The Fonda Group Inc.) **WHEREAS**, Assignee has completely and timely performed all of the Obligations in accordance with the terms and provisions of the Security Agreement and Assignor desires to release its security interest and assign all right, title and interest in the Trademark Collateral to Assignee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its Security Interest and assigns all of its right, title and interest in the Trademark Collateral to Assignee and, without representation, warranty or recourse of any kind, revests Assignee with full title to the Trademark Collateral.
