ASSIGNMENT OF RIGHTS UNDER ASSET PURCHASE AGREEMENT

This Assignment of Rights under Asset Purchase Agreement is made as of July 23, 2001 by Smithfield Foods, Inc., a Virginia corporation ("Smithfield") to QTF Acquisition Sub., Inc., a Delaware corporation and a wholly-owned indirect subsidiary of Smithfield ("QTF").

1. Smithfield and Gorges/Quik-to-Fix Foods, Inc. ("Seller") are parties to an Asset Purchase Agreement dated as of July 11, 2001 (the "Agreement") pursuant to which Seller agreed to sell to Smithfield substantially all of the assets of the Business (as defined in the Agreement).
2. Section 17 of the Agreement provides that Smithfield may assign its rights under the Agreement to a wholly-owned direct or indirect subsidiary.
3. Smithfield desires to assign its rights under the Agreement to QTF.

ASSIGNMENT

Smithfield hereby assigns all of its rights and obligations under the Agreement to QTF (the "Assignment"). QTF hereby accepts the Assignment and agrees to perform all of the obligations of Smithfield under the Agreement. Smithfield hereby guarantees the performance of all obligations of QTF under the Agreement, subject to Section 24 of the Agreement.
