

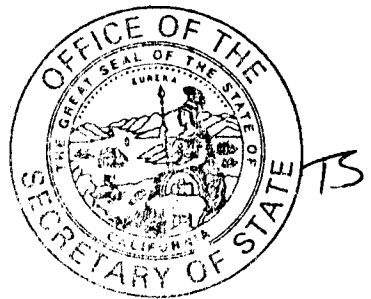
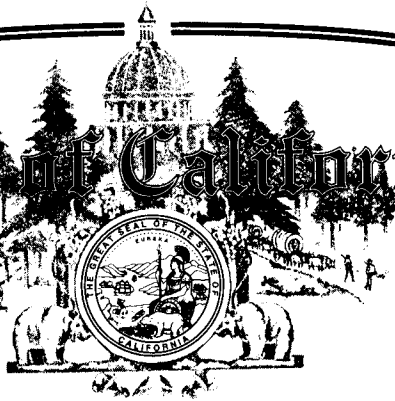

1. That Laurence V. Goddard is the President and Brian Chait is the Secretary of this corporation.



3. The board of directors of WACO INTERNATIONAL DISTRIBUTION CORPORATION duly adopted the following resolution:


