

Assignor further covenants and agrees, for itself and its successors and assigns, that it will assist Assignee in the recordation of this Assignment with any governmental entity, and that it will execute and deliver to Assignee any and all additional documents and do any such further acts necessary to vest in Assignee the rights hereby conveyed.

Assignor further covenants that it has full right to convey the entire right, title, license, interest and privilege herein assigned.

All said right, title, license, interest and privilege shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.
