No. 2171156, together with the goodwill of the business represented by each of the foregoing, and all other corresponding rights that are or may be hereafter secured under the laws of the United States or any foreign country, now or hereafter in effect (collectively, the "Mark"), for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely ~~as the same would have been held and enjoyed by Assignor if this Assignment had not been~~ made, together with all income, royalties, or payments due or payable as of the Effective Date or thereafter, including with out limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.

Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entity or agency in any applicable foreign country, to record Assignee as the assignee and owner of the Mark.

Assignor shall take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), reasonably requested by Assignee within the next three (3) years to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (1) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; (2) the

prosecution or defense of any interference, opposition, or other proceedings that any arise in connection with the rights assigned herein; (3) obtaining any additional trademark protection relating to rights assigned herein; and (4) in the implementation of perfection of this Assignment in all applicable jurisdictions throughout the world.
