TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of July 31, 2002 (the "Effective Date") by and between ACCO WORLD CORPORATION, a Delaware corporation ("Assignor"), and CRAWFORD INDUSTRIES LLC, an Indiana limited liability company ("Assignee").

WHEREAS, Assignee and ACCO Brands Inc., a Delaware corporation and affiliate of Assignor ("ACCO"), have entered into that certain Asset Purchase Agreement dated July 31, 2002 (the "Asset Purchase Agreement"), pursuant to which ACCO has agreed to cause Assignor to assign to Assignee (a) those trademarks and trade names and United States trademark registrations and applications therefor identified and set forth on Schedule A (the foregoing collectively referred to herein as the "Marks"); and (b) the goodwill of the business associated with the Marks; and

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign the entire right, title and interest in and to the Marks, together with the goodwill of the business with which the Marks are used;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee its entire right, title and interest in and to the Marks, together with the goodwill of the business with which the Marks are used, for the United States, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner of the Marks.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

To the extent any provision herein is inconsistent with the Asset Purchase Agreement, the provisions of the Asset Purchase Agreement shall control.

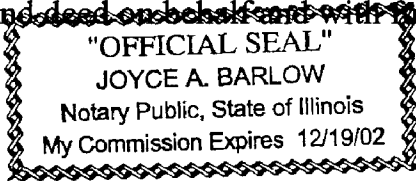

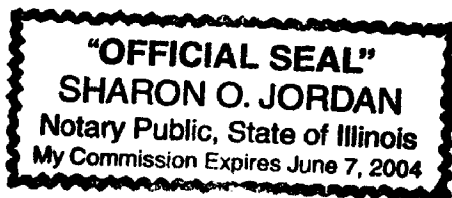
