ASSIGNMENT

In consideration of One Dollar and other good and valuable considerations, the receipt and sufficiency whereof are hereby acknowledged, **COUNTRY FLAME TECHNOLOGIES, INC.**, a Missouri corporation, having its principal place of business at Post Office Box 151, Mount Vernon, Missouri 65712 (hereinafter "*Assignor*"), hereby assigns to **AMERICAN PRODUCTS, LLC.** a Missouri company, having its principal place of business at 597 Evergreen Road, Strafford, Missouri 65757-9634 (hereinafter "*Assignee*"), its successors and assigns, the entirety of its right, title and interest in the trademark and service mark COUNTRY FLAME, and all good will associated with that mark. The mark is more particularly described as originally disclosed in an application for Registration of Trademark, Serial No. 73/275624, which was filed in the United States Patent and Trademark Office on August 25, 1980, and which was registered June 15, 1982 on the Principal Register of Trademarks, as Registration Number 1,107,708, and any and all other applications for Registration of Trademark which the undersigned may file, either solely or jointly with others, for a derivative or association mark and in any and all Trademark Registrations for derivative or association marks. Nothing in this Assignment limits the transfer of rights from Assignor to Assignee.

Assignor asserts that it knows of no prior or existing claims of infringement against the mark COUNTRY FLAME. Assignor asserts that it knows of no reason that Assignee can not legally own the mark COUNTRY FLAME by this assignment, including the right to seek registration of the same with the United States Patent and Trademark Office.

Further, Assignor hereby assigns to Assignee all rights and interest in all intellectual property owned or controlled by Assignor, whether under common law, statute or

similar law, including, but not limited to, trademarks, copyrights, designs, images, appearances, likenesses and all goodwill associated with the COUNTRY FLAME mark and which Assignor has associated with the manufacturing and marketing of wood burning stoves, fireplaces and related products.

For said considerations the Assignor hereby agrees, upon the request, and at the expense of said Assignee, its successors and assigns, to execute any and all trademark applications or other documents necessary to prosecute and protect the trademark and service mark COUNTRY FLAME as well as all other intellectual property transferred by this agreement.

Assignor retains no rights to the mark COUNTRY FLAME and acknowledges that this assignment of rights includes all good will associated with the mark. Assignor acknowledges the rights of Assignee in the mark COUNTRY FLAME upon execution of this Assignment.
