dated as of December 18, 2003, by QQUEST SOFTWARE SYSTEMS, INC., a Delaware corporation (the "Grantor") and FINOVA MEZZANINE CAPITAL INC., f/k/a Sirrom Capital Corporation (the "Secured Party").

**WHEREAS**, the Grantor and the Secured Party entered into an agreement (the "Security Agreement") which was recorded with the United States Patent and Trademark Office at Reel 1762, Frame 0514 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party;

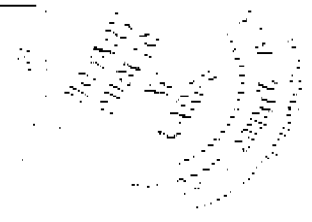
