



WHEREAS, Assignee is the owner of U.S. Trademark Registration No. 1,260,749 for SABHI.

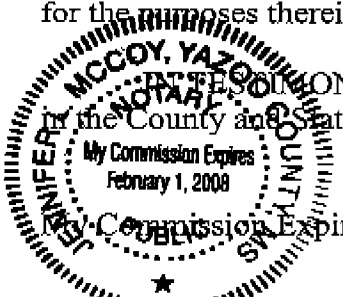
