FIRST: The name of the corporation is Professional Travel Corporation

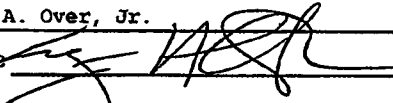
SECOND: The following amendment to the Articles of Incorporation was adopted on December
