IP ASSIGNMENT

This agreement ("Agreement") is being entered into by and between Ricon Corp. (hereinafter "RICON"), a California corporation, and Concord Elevator Inc. (hereinafter "CONCORD"), an Ontario, Canada corporation, and is effective upon its full execution.

RECITALS:

A. CONCORD was formerly a wholly-owned subsidiary of RICON.

B. The parties were involved in certain transactions which resulted in RICON no longer owning the stock of CONCORD, either directly or indirectly, and the two corporations having no corporate relationship (hereinafter "SEPARATION TRANSACTION").

C. It is desired that certain intellectual property assets be owned by CONCORD.

D. The U.S. Patent Office erroneously identified RICON as the owner of U.S. Patent No. 5,533,594 on the face of the letters patent and the parties wish to correct this error in the Patent Office records.

Wherefore, in consideration of the above recitals, and other consideration, the legal sufficiency of which and receipt is acknowledged, the parties agree as follows:

1. RICON hereby acknowledges CONCORD's ownership of U.S. Pat. No. 5,533,594 entitled Chairlift With Positioning Carriage and Swivel Mechanism With Safety Interlock, and therefore assigns to CONCORD, its successors and assigns, all right, title, and interest in and to U.S. Pat. No. 5,533,594 which may be owned by RICON.

2. RICON hereby assigns to CONCORD, its successors and assigns, all right, title and interest (U.S. and foreign) in and to the following trademarks, their related
