WHEREAS SHS owns 100% of the limited liability company interests of Sierra Healthstyles, LLC, a Delaware limited liability company ("Assignee");



NOW, THEREFORE, for good and valuable consideration as set forth herein, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to Assignee, its successors, legal representatives and assigns, all of Assignor's right, title and interest in, to and under the Trademarks, together with the goodwill of the business associated with the Trademarks (including, without limitation, all proceeds thereof and the rights to sue for past, present and future damages), the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale and assignment not been made.

Assignor hereby authorizes and requests the Commissioner of Trademarks to record Assignee as the owner of all such Trademarks and to issue all registrations for said Trademarks to Assignee, as assignee of the U.S. trademark registrations and applications listed on Schedule A, for the sole use and enjoyment of the Assignee, its successors, legal representatives and assigns.
