TERMINATION OF TRADEMARK SECURITY INTEREST OF
FLEET CAPITAL CORPORATION

THIS TERMINATION OF TRADEMARK SECURITY INTEREST (hereinafter the "Agreement"), dated August 29, 2003, executed by Fleet Capital Corporation (the "Secured Party"), and delivered to Brotech Corp., a Delaware corporation with a principal place of business at 150 Monument Road, Suite 202, Bala Cynwyd, Pennsylvania 19004 and Purolite International Limited, a company registered in the United Kingdom under number 1840987 with its chief executive office at Cowbridge Road, Pontyclun, Mid Glamorgan CF72 8YL (collectively the "Assignors") releasing all security interests of Secured Party in the Trademark Collateral (as defined below).

WHEREAS, the Secured Party recorded a Trademark Security Agreement (United States Trademarks) dated March 1, 2000 in the United States Patent and Trademark Office at Reel 2074, Frame 0874 (the "Security Agreement");


WHEREAS, pursuant to the Security Agreement, and in consideration of and pursuant to the terms of the Loan Agreement (as defined in the Security Agreement), the Assignor granted to the Secured Party a lien and security interest in all of the Assignors' present and future right, title and interest in and to the Trademark Collateral (as defined in the Security Agreement), together with all the goodwill of Assignor associated with and represented by the Trademark Collateral and the registration thereof to secure the payment and performance of all the Obligations of all Borrowers (as defined in the Security Agreement) under the Loan Documents (as defined in the Security Agreement); and

WHEREAS, the Obligations have been partially repaid (other than a \$1,500,000 overadvance amount made available by the Secured Party, which shall not be secured by the Trademark Collateral) and the Secured Party desires and is willing to terminate all of its security interest in and lien upon the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby terminates all of the Secured Party's security interest in and lien upon the Trademark Collateral, and reassigns any and all interest it may have in such Trademark Collateral to Assignors.
