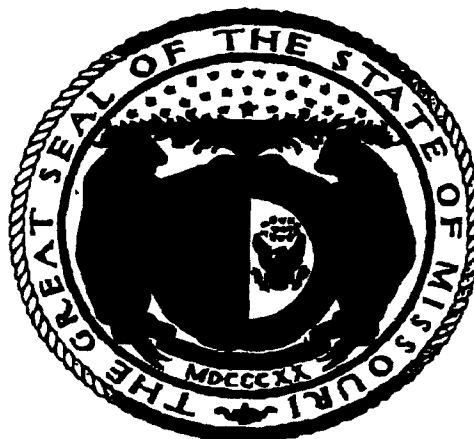

ARTICLES / CERTIFICATE OF MERGER

1. The corporations listed as Missouri public benefit corporations on Exhibit A of the Plan attached hereto (referred to herein as the "Missouri HM Subsidiaries") and the corporations listed as Kansas non-stock, not-for-profit corporations on said Exhibit A (referred to herein as the "Kansas HM Subsidiaries") shall merge into Health Midwest, a Missouri public benefit corporation, and Health Midwest shall be the surviving corporation.

2. In accordance with Section 355.631 of the Revised Statutes of Missouri, a copy of the Plan and Agreement of Merger ("Plan") is attached as ATTACHMENT I to the Articles/Certificate of Merger filed with the Missouri Secretary of State and the Kansas Secretary of State. In accordance with Section 17-6701(c) of the Kansas Statutes Annotated, the Plan also is on file at the principal place of business of Health Midwest, which is located at 2304 E. Meyer Blvd., Suite A-10, Kansas City, Missouri 64132, and Health Midwest has and shall furnish a copy thereof, upon request and without cost, to any sole member referred to in paragraph 4 below.

3. Health Midwest, having no members, approved the Plan on its own behalf through a vote of its board of directors that was sufficient for approval.

4. The sole member of each Missouri HM Subsidiary and each Kansas HM Subsidiary (generically referred to herein without reference to the state of incorporation as a "HM Subsidiary") is listed on Exhibit A of ATTACHMENT I hereto, and each sole member approved the Plan. The number of votes entitled to be cast with respect to each HM Subsidiary was one (1). The number of votes cast in favor of the Plan with respect to each HM subsidiary was one (1) and the number of votes cast against the Plan with respect to each HM Subsidiary was zero (0).

5. Upon the Effective Date, the Articles of Incorporation and Bylaws of Health Midwest as in effect immediately prior to the Effective Date shall be the Articles of Incorporation and Bylaws of the surviving corporation upon the Effective Date of the Merger.

6. The Effective Date of the Merger shall be April 1, 2003.

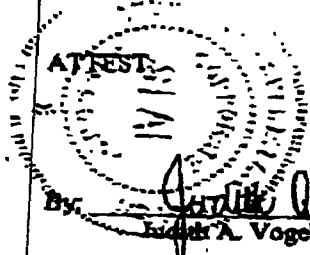
