CERTIFICATE OF AMENDMENT
OF THE CERTIFICATE OF INCORPORATION
OF
MEDIAAMERICA, INC.

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

WE, THE UNDERSIGNED, being respectively the Vice President and Secretary of MediaAmerica, Inc. (the "Corporation") hereby certify:

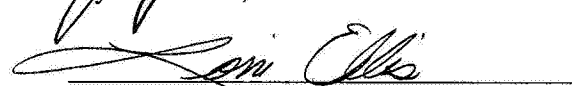
1. The name of the Corporation is MediaAmerica, Inc. (f/k/a Jones MAI, Inc.)
2. The Certificate of Incorporation of the Corporation was filed with the Department of State on the 26th day of June, 1998, and an amendment thereto was filed with the Department of State on the 16th day of July, 1998 to change the Corporation's name from Jones MAI, Inc. to MediaAmerica, Inc.
3. (a) The Certificate of Incorporation is amended to change the name of the Corporation from MediaAmerica, Inc. to Jones MediaAmerica, Inc.

(b) To effect the foregoing, Article 1 relating to the name of the Corporation is amended to read as follows:

"FIRST: The name of the corporation is Jones MediaAmerica, Inc. (the "Corporation")."
4. The amendment was authorized by the unanimous written consent of the Board of Directors of the Corporation followed by the unanimous written consent of the Shareholders of the Corporation.
