ASSIGNMENT OF TRADEMARK

WHEREAS, the Northern California Chapter of the National Electrical Contractors Association (the "Assignor"), a California CORPORATION, an officially sanctioned chapter of Assignee, has adopted and is using the trademark "NECA WEST" (the "Trademark") and has filed an application for registration of the Trademark with the United States Patent and Trademark Office (Serial No. 78120830); and

WHEREAS, to promote and maintain the mutually beneficial working relationship between the parties, the Assignor desires by means of this Assignment of Trademark (this "Assignment") to assign, convey and transfer to the Assignee all of the rights, title and interest held by Assignor in the Trademark and the above identified application for registration of the Trademark.

NOW THEREFORE, in consideration of the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said Assignor does hereby sell, assign, convey and transfer unto said Assignee all of the rights, title and interest held by Assignor in the Trademark and the above identified application for registration of the Trademark, together with the good will of the business associated with the Trademark, in the United States of America, and in its colonies, territories, and dependencies, and also in all countries foreign to the United States of America, the same to be held and enjoyed by Assignee for its own use, and for the term or terms for which said Trademark has been registered as fully and entirely as the same would have been held and enjoyed by Assignor, including all rights to injunctive relief, damages or profits, due or accrued, arising out of past infringement of said Trademark or injury to the said goodwill, and the right to sue for and recover the same in its, the Assignee's, own name.

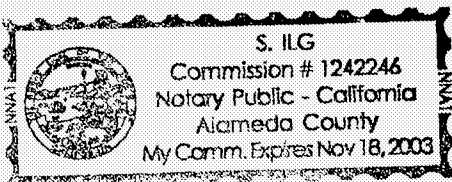
