CERTIFICATE OF CONVERSION
OF
RELIANT PHARMACEUTICALS, LLC
(a Delaware limited liability company)
TO
RELIANT PHARMACEUTICALS, INC.
(a Delaware corporation)

RELIANT PHARMACEUTICALS, LLC, a limited liability company formed and existing under the Delaware Limited Liability Company Act, as amended (the "LLC Act"), does hereby certify as follows:

FIRST: That the entity Reliant Pharmaceuticals, LLC was first formed as a corporation incorporated under the laws of the State of Delaware on August 31, 1999 under the name "Bay City Pharmaceuticals, Inc."

SECOND: That on April 17, 2000 Bay City Pharmaceuticals, Inc. filed a Certificate of Amendment changing its name to "Reliant Pharmaceuticals, Inc."

THIRD: That on July 6, 2000, Reliant Pharmaceuticals, Inc. filed a Certificate of Conversion converting from a corporation to a limited liability company formed under the laws of the State of Delaware, under the name "Reliant Pharmaceuticals, LLC."

FOURTH: That, pursuant to Section 18-216 of the LLC Act and Section 265 of the Delaware General Corporation Law, Reliant Pharmaceuticals, LLC shall convert from a limited liability company to a corporation incorporated under the laws of the State of Delaware.

FIFTH: That the name of the corporation shall be "Reliant Pharmaceuticals, Inc." as set forth in the Certificate of Incorporation filed contemporaneously herewith in accordance with subsection (b) of Section 265 of the Delaware General Corporation Law.


SIXTH: That Reliant Pharmaceuticals, LLC is a limited liability company existing under the laws of the State of Delaware.

SEVENTH. That the conversion shall become effective at 12:00 a.m., Eastern Standard Time, on April 1, 2004.

EIGHTH: That each of the conversion of Reliant Pharmaceuticals, LLC to Reliant Pharmaceuticals, Inc. and the Certificate of Incorporation of Reliant Pharmaceuticals, Inc. has been approved in accordance with the provisions of Section 265 of the Delaware General Corporation Law and Section 18-216 of the LLC Act and in the manner provided for in the Third Amended and Restated Limited Liability Company Operating Agreement of Reliant Pharmaceuticals, LLC, dated as of September 25, 2003, which is the agreement that governs the internal affairs of Reliant Pharmaceuticals, LLC and the conduct of its business.

IN WITNESS WHEREOF, Reliant Pharmaceuticals, LLC has caused this Certificate of Conversion to be executed by its duly authorized officer as indicated below this 31st day of March, 2004.
