

TRADEMARK ASSIGNMENT

WHITCO, INC., an Arkansas corporation (the "Assignor"), is the owner of the trademarks, service marks, registrations and pending applications listed on Exhibit A attached hereto (collectively, the "Trademarks").

The Assignor has agreed, pursuant to the Asset Purchase Agreement dated as of the date hereof by and among the Assignor and Alkota Cleaning Systems, Inc., a South Dakota corporation (the "Assignee"), to assign all of its right, title and interest in and to the Trademarks to the Assignee.

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt of which is hereby acknowledged:

1. The Assignor sells, assigns and transfers to the Assignee, its successors and assigns, the Assignor's entire right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized thereby and also including all common law trademark, service mark and trade name rights in the Trademarks, as well as the right to recover and have damages and profits for past infringement, if any.

2. The Assignor further agrees, for itself and its legal representatives, to provide reasonable assistance to the Assignee, at the Assignee's expense, in the prosecution before the United States Patent and Trademark Office and the Federal Courts of the United States of any matters relating to the Trademarks, including renewals, continuations, divisions, reissues, and substitutions, that the Assignee elects to make covering the Trademarks.

3. This Assignment will be binding upon the successors and assigns of Assignor and will inure to the benefit of the successors and assigns of the Assignee.

4. The Assignor agrees that it will not execute any writing nor do any act whatsoever conflicting with this Assignment, and that the Assignor, its successors and assigns, will at any time upon request, without further or additional consideration, execute such additional writings and do such additional acts, including the giving of testimony, as the Assignee or its successors and assigns may deem necessary or desirable in the enjoyment of this Assignment, and in enforcing any rights relating hereto.

5. The Commissioner of Patents and Trademarks of the United States is authorized and requested to recognize the Assignee as the owner of the Trademarks, as applicable. The Assignor also authorizes and requests the equivalent authorities in foreign countries to issue the Trademarks of foreign countries to the Assignee as requested.
