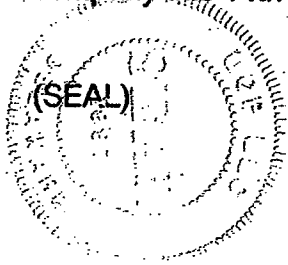

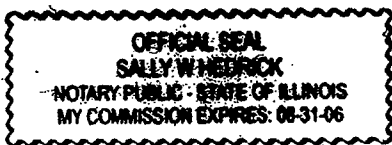

**BILL OF SALE**

This Bill of Sale (this "Bill of Sale") is made as of this 20th day of March, 2003 from UOP LLC, a Delaware limited liability company ("Seller") and Dorf Ketal Chemicals LLC, a Delaware limited liability company ("Buyer").

WHEREAS, Buyer and Seller have entered into that certain Intellectual Property and Asset Purchase Agreement dated as of March 20th, 2003 (the "Purchase Agreement") pursuant to which Buyer shall purchase from Seller and Seller shall sell to Buyer substantially all of the assets (other than the Excluded Assets, as defined in the Purchase Agreement) which are used in or otherwise relate to the Seller's Plastics Additive Business Schedule 1.0 (the "Product Lines") as defined in the Purchase Agreement; and

WHEREAS, upon the terms and subject to the conditions of the Purchase Agreement, Seller desires to sell, convey, assign and transfer to Buyer and Buyer desires to purchase and acquire from Seller substantially all of the assets comprising the Business as set forth in Section 1.1(a) of the Purchase Agreement (the "Purchased Assets").

NOW, THEREFORE, pursuant to the Purchase Agreement and for valuable consideration as set forth therein, the receipt and sufficiency of which are hereby acknowledged, and of the mutual covenants set forth, Seller hereby sells, conveys, assigns, transfers and delivers to Buyer, its successors and assigns, forever, as an entirety, all of the right, title and interest of Seller in the assets which are used in or otherwise relate to the Product Lines as set forth on Exhibit 1 attached hereto.

To have and to hold subject to the terms hereof, all of the assets and properties hereby sold, conveyed, transferred, assigned and delivered unto Buyer, its successors and assigns, forever.

This Bill of Sale shall be binding and inure to the benefit of the parties hereto and their respective successors and assigns.

(iii) the IP Assets. For the purposes of this Agreement, the term "IP Assets" means the intellectual property specified in Schedule 1.1(a)(iv) to the Purchase Agreement.
