**PARTIAL RELEASE OF TRADEMARK
COLLATERAL SECURITY AND PLEDGE AGREEMENT**

This PARTIAL RELEASE OF TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT ("Partial Release") is made as of the 15th day of April, 2004, by and between PNC BANK, NATIONAL ASSOCIATION, a national banking association, as Secured Party and Releasing Party, having an office located at One South Wacker Drive, Suite 2980, Chicago, Illinois 60606 ("Secured Party") and GFTCO, INC., an Illinois corporation, as Borrower and Receiving Party, having an office at 700 Woodlands Parkway, Vernon Hills, Illinois 60061 ("Borrower")

WHEREAS, Secured Party and the Borrower are parties to a certain Trademark Collateral Security and Pledge Agreement of February 28, 2004 wherein Borrower granted the Secured Party a security interest in its trademarks, include those trademarks listed on Exhibit A, attached hereto;
