TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT

This TRADEMARK AND DOMAIN NAME ASSIGNMENT AGREEMENT ("Agreement"), is made as of this 26th day of June, 2003, by and among SPAM COP, INC., a corporation organized under the laws of Washington ("Spam Cop"), JULIAN HAIGHT ("Mr. Haight" and together with Spam Cop, the "Sellers" or sometimes collectively as the "Seller") and REDLITE ACQUISITION CORPORATION, a corporation organized under the laws of Delaware (the "Buyer").

WHEREAS, Seller is the owner of the trademarks, trade names, trade styles, business names and service marks (the "Trademarks"), and Internet domain names (the "Domains") all as set forth in Attachment A hereto, all common law rights relating thereto, and all registrations and applications relating thereto, the accompanying goodwill and that portion of the business represented and symbolized thereby and associated therewith (collectively, the "Rights");

WHEREAS, Seller, IronPort Systems, Inc. a Delaware corporation ("IronPort"), and Buyer, a wholly owned subsidiary of IronPort, have entered into an Asset Purchase Agreement, dated as of June 25, 2003, pursuant to which Seller has agreed to transfer and assign the Trademarks and Domains to Buyer; and

WHEREAS, Seller is desirous of transferring and assigning to Buyer, and Buyer is desirous of acquiring, the Rights of the Trademarks and Domains.

NOW, THEREFORE, effective as of the date hereof, by this document, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller does hereby sell, assign, and transfer to Buyer, and its successors and assigns, the entire right, title and interest in and to the Trademarks and Domains and (i) all applications and registrations which have been or may be filed or issued in respect thereto and any renewals thereof, (ii) all goodwill symbolized by and associated with the business conducted under the Trademarks and Domains and that portion of the business represented and symbolized by the Trademarks and Domains, (iii) all income, royalties, damages, and payments hereafter due or payable in respect thereto, (iv) all causes of action by Seller against any third party (either in law or in equity) and the right to sue, counterclaim, and recover for past, present, or future infringement of the Trademarks and Domains or other rights transferred and assigned to Buyer under this Agreement, and (v) all rights corresponding to the foregoing throughout the world.

In order to effect the transfer of the Domains, Seller shall, at its expense, submit all appropriate forms to Network Solutions, Inc., or any other domain name registrar through which it acquired any or all of the Domains, and execute such other forms or documents as may be reasonably necessary to transfer such Domains to Buyer.

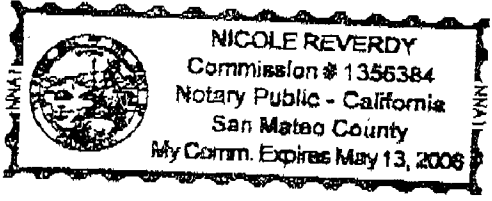
