WHEREAS, Assignor wishes to herein memorialize said assignment, transfer, and sale of the Trademarks to Assignee.



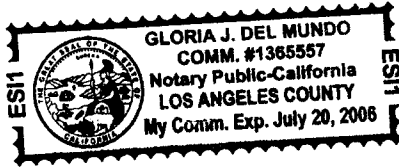
