TRADEMARK ASSIGNMENT

Without limiting the generality of the foregoing, Assignor hereby grants to Assignee the power to appoint agents in the countries listed in Exhibits A and B for the purpose of recording this assignment. Assignor hereby consents to the recordation of this assignment in the countries listed in Exhibits A and B and any other countries as appropriate.

Assignee hereby accepts the assignment of the Marks, registrations listed on Exhibits A and B, and all other rights described in this assignment.



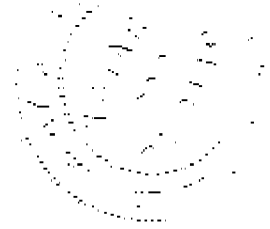
