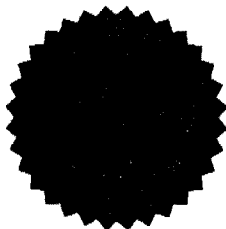

Provider HealthNet Services Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), hereby certifies as follows:

FIRST: The Corporation's Board of Directors has adopted a resolution proposing, adopting and declaring advisable the following amendment (the "Amendment") to the Corporation's Amended and Restated Certificate of Incorporation dated April 4, 2002 in accordance with the provisions of Sections 141 and 242 of the Delaware General Corporation Law, as amended from time to time (the "DGCL"):

RESOLVED, that Article I of the Corporation's Amended and Restated Certificate of Incorporation be, and it hereby is, deleted in its entirety and replaced with the following:

ARTICLE I
NAME

The name of the corporation is PHNS Inc.;

SECOND: The Corporation's stockholders have approved such Amendment by written consent in accordance with the applicable provisions of Sections 228 and 242 of the DGCL.
