

ASSIGNMENT

WHEREAS, The Monarch Company, Inc., a Massachusetts corporation, having a principal address at 4780 Jett Road, Atlanta, Georgia 30327 ("Assignor"), assigned on December 15, 2000, the trademarks KICKAPOO JOY JUICE and KICKAPOO JOY JUICE & Design and the U.S. registrations therefor, Reg. Nos. 827,629 and 836,024, respectively (the "Marks"), to Amistar Acquisition Corp., a Delaware corporation, having a principal address at 3424 Peachtree Road N.E., Atlanta, Georgia 30326 ("Assignee"); and

WHEREAS, Assignee is desirous of having a written document for recording in the United States Patent and Trademark Office to reflect that it acquired all rights, title and interest in and to the Marks, the goodwill of the business symbolized thereby and the registrations therefor, subject to a contingent reversionary interest pursuant to an agreement between Assignor and Capp Enterprises, Inc., dated March 7, 1999.

NOW THEREFORE, good and valuable consideration being extant, Assignor has assigned and hereby assigns to Assignee, **effective as of December 15, 2000**, all of its rights, title and interest in and to the marks KICKAPOO JOY JUICE and KICKAPOO JOY JUICE & Design, the goodwill of the business symbolized thereby, and U.S. Reg. Nos. 827,629 and 836,024, subject to the aforesaid contingent reversionary interest of Capp Enterprises, Inc.

Assignor has further assigned and hereby assigns to Assignee, effective December 15, 2000, all right to sue for, to receive and to hold damages and profits accruing from past infringement of the marks KICKAPOO JOY JUICE and KICKAPOO JOY JUICE & Design.
