RELEASE, DISCHARGE AND UNDERTAKING

TO: Algoma Steel Inc.

AND TO: Bank of America, N.A. (acting through its Canada branch) (formerly Bank of America, National Association)

AND TO: Her Majesty the Queen in right of Canada

AND TO: Torys LLP ("Torys")

AND TO: Ogilvy Renault ("OR")

RE: Amended and Restated Loan Agreement (the "**Loan Agreement**") dated as of January 29, 2002 between Algoma Steel Inc. (the "**Borrower**"), the lenders from time to time party thereto and Bank of America, N.A. (formerly Bank of America, National Association), as Arranger, Collateral Agent, Syndication Agent, Documentation Agent, Administrative Agent and L/C Issuer (in its capacity as agent, the "**Agent**").

The Lenders have extended financing to the Borrower under the Loan Agreement, and the Obligations are collectively secured by certain security on the property of the Borrower held by the Agent for on behalf of itself and for the Lenders. The undersigned is advised that pursuant to a new loan and security agreement dated as of September 3, 2003 between, among others, Bank of America, N.A. (acting through its Canada branch) (formerly Bank of America, National Association), as agent (the "**New Agent**") for and on behalf of a new syndicate of lenders and the Borrower (the "**New Loan Agreement**"), has required this undertaking as a condition of such lenders providing financing to the Borrower for the repayment of the Obligations.

Defined terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Loan Agreement.

Subject to the receipt by the Lenders of the Payout Amount (as defined below) and the concurrent assumption by the New Agent of the letters of credit outstanding under the Loan Agreement, and except as provided herein, the Agent, for and on behalf of itself and each of the Lenders, hereby acknowledges and agrees that:

- a) payment of the Payout Amount and the concurrent assumption by the New Agent of the letters of credit outstanding under the Loan Agreement will constitute payment in full of all of the Borrower's indebtedness and obligations to the undersigned and the Lenders with regard to the Obligations;
- b) effective upon receipt of the Payment Amount, the Loan Agreement, the other Loan Documents and all other agreements executed and delivered in connection with the Loan Agreement, except for any letters of credit issued under the Loan Agreement and being continued under the New Loan Agreement (the "**Letters of Credit**"), will terminate and the Borrower, and any other obligor under or in connection with the Loan Agreement, including without limitation Her Majesty the Queen in right of Canada, the other Loan Documents or any such other agreements, including without limitation the Government Guarantee, will have no further liabilities or obligations thereunder;

- c) all security interests, liens and other encumbrances granted by the Borrower (or by any predecessors thereto) to the Agent, on behalf of itself and each of the Lenders, are released and, in this regard, the Agent, on behalf of itself and each of the Lenders, hereby authorizes the release and discharge of (i) all mortgages, hypothecs, charges and other security agreements or instruments presently held by the Agent, on behalf of itself and each of the Lenders, in any property and assets of the Borrower, whether securing any obligations of the Borrower (direct or indirect; absolute or contingent) or securing any obligation of any third party and (ii) all guarantees, indemnities, mortgages, charges and other security agreements presently held by the undersigned, which guarantee or otherwise support (directly or indirectly) any obligation, including without limitation the Government Guarantee, of the Borrower to the Agent, including without limitation releases of interests in casualty insurance, releases of guarantees for the indebtedness of the Borrower and any collateral security held therefor;
- d) the Borrower and its counsel are hereby authorized and directed, without further notice, to deliver a copy of this agreement to any insurance company, insurance broker, bank, landlord, tenant, warehouseman or other person to evidence the termination and release of all security interest and liens which the Borrower or any other obligor has granted to the Agent or any Lender under the Loan Agreement, and thereafter, with the exception of the Letters of Credit, any contract, agreement, control, blocked account agreement or deposit agreement, bailee or warehousemen agreement, landlord or collateral access agreement, non-disturbance and attornment agreement, tenant estoppel agreement, commitment to deliver insurance certificates and proceeds and the like executed by any such party in favour of the Agent or any Lender in connection with the transactions contemplated by the Loan Agreement shall be automatically terminated, without further action of or consent by the Agent; and
- e) any Collateral, if any, in the Agent's or any of the Lenders' possession shall be delivered or returned to the Borrower or its counsel.

Subject to the receipt by the undersigned of the Payout Amount, the undersigned hereby irrevocably authorizes its counsel, Ogilvy Renault, and its counsel's agents to register discharges of all security registrations made pursuant to, and to execute and deliver to the Borrower or its counsel releases of all security filings in Patent and Trademarks or Copyright Offices filed in favour of the Agent or the Lenders in connection with the transactions contemplated, by the Loan Agreement, or any predecessor loan agreement, including without limitation, those listed in the attached Schedule A, without the signature of the Agent or any of the Lenders.

The undersigned agrees that, at any time and from time to time, it will promptly execute and deliver such other termination statements or other agreements and instruments in form and substance reasonably satisfactory to the Borrower, or any other obligor, including without limitation Her Majesty the Queen in right of Canada, as the Borrower or such Person may reasonably request to further evidence and effect the release of the security interests and liens granted to the Agent pursuant to the Loan Agreement, the other Loan Documents or any other agreement or instrument executed and delivered in connection therewith. Further, the undersigned hereby represents and warrants that it has not sold, transferred, assigned or otherwise encumbered any of the security or its interests in the assets of the Borrower, or any other obligor.




