TERMINATION OF
SUPPLEMENTAL SECURITY AGREEMENT
(TRADEMARKS AND TRADEMARK LICENSES)

THIS TERMINATION OF SUPPLEMENTAL SECURITY AGREEMENT is made and executed as of April 16, 2004, by and between Carneros Creek Winery, LLC., a California limited liability company (the "Company") and Pacific Coast Farm Credit Services ACA ("Lender").

RECITALS

A. The Company and Lender entered into that certain Supplemental Security Agreement (Trademarks and Trademark Licenses) as of November 8, 1999 (the "Security Agreement") which granted Lender a security agreement in the trademarks set forth on Exhibit A attached hereto (the "Trademarks").

B. The Security Agreement was recorded with the United States Patent and Trademark Office on December 15, 1999, as Document Number 101224684 in Reel 1998, Frame 0533.

C. The Company and Lender now wish to terminate the Security Agreement.

NOW, THEREFORE, in consideration of the mutual agreements contained herein, the parties hereto agree as follows:

AGREEMENT

1. Termination. The Company and the Lender hereby agree to terminate the Security Agreement as of the date set forth above. The Lender hereby fully and completely releases its security interest in the Trademarks created by the Security Agreement.

2. General Provisions.


2.1. Entire Agreement. This Agreement contains the entire agreement between the parties, and supersedes all prior negotiations, drafts, and other understandings which the parties may have had concerning the subject matter hereof.

2.2. Counterparts. This Agreement may be executed in any number of counterparts, and each such counterpart shall be deemed to be an original instrument. All such counterparts together shall constitute one and the same Agreement.

2.3. Governing Law. This Agreement shall be governed by, and construed in accordance with, the law of the State of California, without giving effect to principles of conflict of laws.


