ASSIGNMENT OF REGISTERED TRADEMARKS

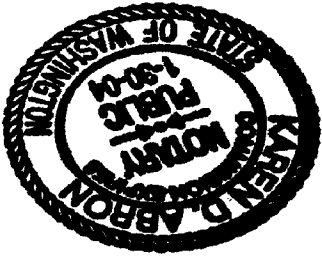

This includes, but is not limited to, any rights with respect to the Trademark that may have accrued in ASSIGNOR's favor from the respective date of first use of any of the Trademark from the Effective Date of this Assignment. ASSIGNOR hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

NOW, THEREFORE, in consideration of good and valuable consideration, ASSIGNOR hereby assigns to ASSIGNEE, all right, title and interest in the United States in and to said Trademark together with the goodwill of the business symbolized by said Trademark and registration thereof.
