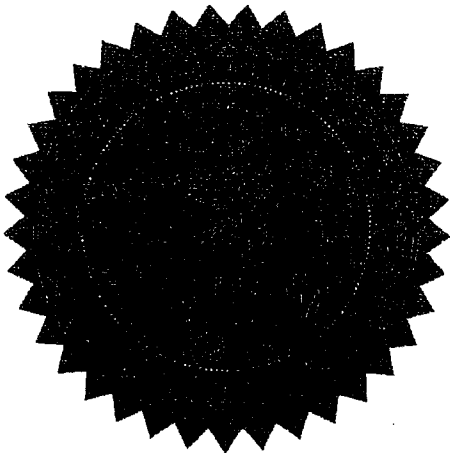

The undersigned certify that:


1. They constitute a majority of the directors now in office of AnyTime Access, Inc., a California Corporation.
