NUNC PRO TUNC DEED OF ASSIGNMENT OF TRADEMARKS

Further, Assignors agree that, upon request and without further compensation from Assignee and its legal representatives and assigns, but at no costs to Assignors, will do all lawful acts, including the execution of papers and the giving of testimony, that may be necessary or desirable for obtaining, sustaining, reissuing or enforcing said trademark and trademark registrations in any countries for said trademark, and for perfecting, recording or maintaining the title of Assignee, its successors and assigns, to said trademark, and any registrations issued for said trademark in any countries.



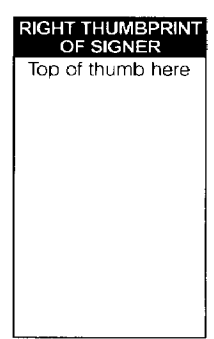
