

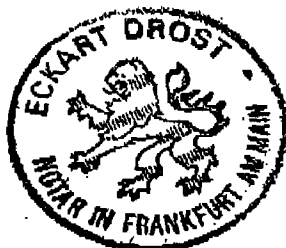

Since this date Röhm GmbH has been the unrestricted legal successor of Agomer Gesellschaft mit beschränkter Haftung, previously Hanau.
2. According to the resolution on conversion of form dated December 20, 2000 Röhm GmbH was transformed into the Röhm GmbH & Co. KG with registered seat in Darmstadt. Röhm GmbH & Co. KG was entered on December 27, 2000 in the Commercial Register of the Darmstadt Local Court under No. HRA 6739. An entry referring to the former Röhm GmbH was also made on the same date. As a consequence, Röhm GmbH & Co. KG with registered seat in Darmstadt, Kirschenallee 17 - 21, 64293 Darmstadt/ Federal Republic of Germany is therefore the unrestricted legal successor of the former Röhm GmbH and also of Agomer Gesellschaft mit beschränkter Haftung previously transferred to Röhm GmbH by merger.
