**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY
(TRADEMARKS)**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (TRADEMARKS) (this "Release") is made as of this 19th day of April, 2004, by LASALLE BANK NATIONAL ASSOCIATION, individually and as successor in interest to Comerica Bank - Illinois ("Lender"), in favor of JAYS FOODS, L.L.C., a Delaware limited liability company (together with its successors and assigns "Borrower").

WHEREAS, Lender made certain credit facilities available to Borrower (the "Loans"), pursuant to which Borrower entered into a Patent, Trademark and License Mortgage signed September 2, 1994 and an Amendment of Patent, Trademark and License Mortgage (collectively, the "Security Agreements"), which Security Agreements were recorded against the U.S. Registered Trademarks set forth on Schedule I attached to this Release (respectively, the "Trademarks"), granting to Lender a continuing security interest in and to the Trademarks and all rights and interests relating thereto (collectively, the "Trademark Collateral"); and

WHEREAS, the Loans have been, or concurrently herewith are being, repaid, the Borrower is selling substantially all of its assets, including without limitation, the Trademark Collateral, and in connection therewith, Borrower has requested that Lender, and Lender has agreed to, release its security interest in and lien on the Trademark Collateral;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby cancels, releases, terminates and no longer claims a security interest in or to all right, title and interest in the Trademark Collateral that Lender received pursuant to the Security Agreements or any other documents, instruments or agreements executed in connection therewith. Lender agrees to execute such other documents and assurances as may be reasonably necessary to carry out the intent of this Release. Lender hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to issue the same to Borrower, in accordance with the terms of this Release.

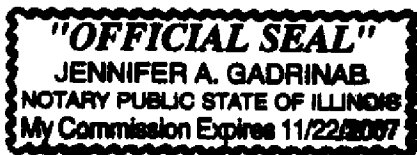
