**TERMINATION
OF
SECURITY INTEREST IN TRADEMARKS**

This Termination of Security Interest in Trademarks (the "Termination") is executed by FB Commercial Finance, Inc., a Missouri corporation, as Secured Party (the "Secured Party"), in favor of iReady Corporation, a Delaware corporation (the "Debtor"), and is effective as of April 20, 2004.

RECITALS

A. Debtor and Sand Hill Capital II, L.P. ("Sand Hill II") entered into a certain Loan Agreement, dated as of October 4, 2000 (the "Agreement") pursuant to which Debtor granted Sand Hill II a security interest in certain collateral including, without limitation, the trademarks and trademark applications listed on Schedule 1 attached hereto and incorporated herein by reference.

B. Sand Hill Capital II, Sand Hill Capital II Q, L.P. and Sand Hill Capital, LLC (collectively, "Grantors") entered into a certain Trademark Security Agreement dated as of December 11, 2000 (the "Trademark Security Agreement") pursuant to which such Grantors granted to the Secured Party a security interest in all of their right, title and interest (including, without limitation, any interest which is a security interest held by the Grantors in the Trademark Collateral, as defined in the Trademark Security Agreement).


C. The Trademark Security Agreement was filed with the Patent and Trademark Office on April 18, 2001, at Reel/Frame 2273/0335.

C. Sand Hill II has advised Secured Party that Debtor has repaid all amounts due to Sand Hill II under the Agreement.

The Secured Party therefore expressly terminates its security interest in the Trademark Collateral, as defined in the Trademark Security Agreement, namely the trademarks and trademark applications listed on Schedule 1 attached hereto and all products and proceeds thereof.
