ASSIGNMENT OF TRADEMARKS

ASSIGNMENT OF TRADEMARKS dated as of September 30, 2003, between **Danskin, Inc.**, a Delaware corporation (the "Assignor"), and **JBT Legwear LLC**, a Delaware limited liability company (the "Assignee").

WITNESSETH:

WHEREAS, Assignee, Assignor, and Pennaco, Inc., a Delaware corporation, have entered into an Asset Purchase Agreement, dated as of September 30, 2003, pursuant to which Assignor and Pennaco, Inc. sold, assigned, and transferred to Assignee certain assets; and

WHEREAS Assignor owns all right, title, and interest in and to all of the trademarks and service marks, and registrations and applications for registration thereof, set forth on Schedule A hereto (the "Trademarks");

WHEREAS, in order to convey the Trademarks to Assignee, Assignor hereby conveys all title and interest in the Trademarks and the goodwill and certain other assets with respect to the Trademarks, as further set forth herein, and Assignee has requested Assignor to make such sale and assignment.


NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that for valuable consideration received, Assignor hereby irrevocably assigns, sells, transfers, and conveys to Assignee:

- (a) the Trademarks;
- (b) all registrations of the Trademarks in the United States, any state of the United States and any foreign countries and localities;
- (c) all extensions, renewals, and continuations of the Trademarks and the registrations referred to in clause (b) above;
- (d) all rights to sue for past, present and future infringements of the Trademarks;
- (e) all packaging, labeling, trade names, service marks, logos, and trade dress including or containing the Trademarks, or a representation thereof, or any variation thereof;
- (f) all licenses and other agreements under which Assignor is licensor, and all fees, rents, royalties, proceeds or monies thereunder, relating to the Trademarks and the use thereof; and
- (g) all goodwill of Assignor's business connected with, symbolized by or in any way related to the items set forth in clauses (a) through (f) above.

This Assignment shall be governed by, construed, applied, and enforced in accordance with the federal laws of the United States of America applicable to trademarks and the laws of

the State of New York, except that no doctrine of choice of law shall be used to apply the laws of any other state of jurisdiction.
