ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS, dated as of January 1, 2004 ("Assignment"), by IMC Chemicals Inc., a Delaware corporation ("Assignor"), in favor of IMC Chemicals Sales Inc., a Delaware corporation ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee, Assignor's entire right, title, benefit, privileges and interest in, to, and under (i) the Trademarks, (ii) the goodwill of the business symbolized by the Trademarks, (iii) all income, royalties, damages, and payments now or hereafter due or payable in respect to the Trademarks, and (iv) all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringement, dilution, or misappropriation of the rights assigned to Assignee, respectively, hereunder, and all rights corresponding thereto throughout the world.


