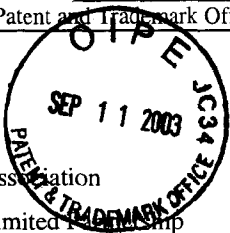

TRADEMARK ASSIGNMENT

THIS AGREEMENT made this *25th* day of *June*, 2003 between

SAirGroup, a corporation duly organised under the laws of Switzerland, having domicile at Hirschengraben 84, 8001 Zurich, Switzerland (hereinafter referred to as "SAirGroup") of the one part, and

Swissport International AG, a corporation duly organised under the laws of Switzerland, having domicile at Flughafenstrasse 55, 8152 Opfikon, Switzerland (hereinafter referred to as "Swissport") of the other part.

WHEREAS SAirGroup is the owner of U.S. Trademark Registration No. 2.367.517 for SWISSPORT & Design, registered in the US Trademarks Office on July 18, 2000 for services in International Classes 35, 37, 39 and 42;

WHEREAS Swissport wishes to acquire possession of the Trademark, together with the goodwill of the business concerned in the services in respect of which the Trademark is registered;

WHEREAS SAirGroup has agreed to transfer the Trademark to Swissport;

WHEREAS Swissport agrees to pay all costs and legal fees associated with the preparation and completion of this Agreement.

NOW THEREFORE, to all whom it may concern, be it known that, in consideration of US\$1.00 and other good and valuable consideration, SAirGroup does hereby assign, transfer and set over unto Swissport the Trademark with the goodwill of the business concerned in the services in respect of which the Trademark is registered in the United States.

SAirGroup authorises and requests the US Patent and Trademarks Office to issue the Trademark to Swissport in accordance with this Agreement.
