
ITCLAIM ASSIGNMENT AND RELEASE OF SECURITY INTEREST



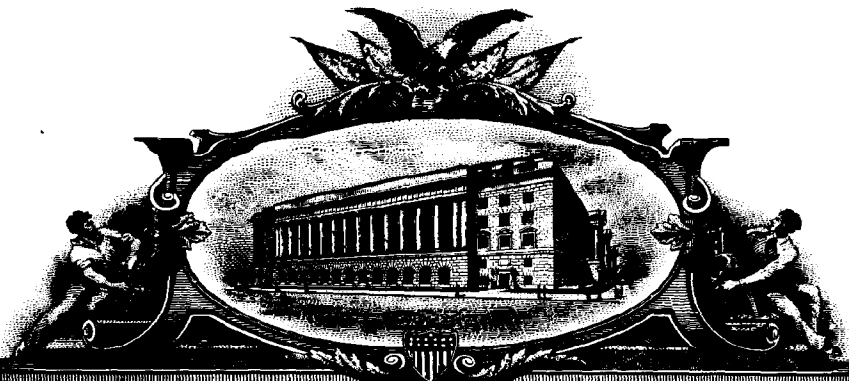
