ASSIGNMENT OF TRADEMARK

WHEREAS, China National Sankwong Fireworks, Co., Ltd., a limited liability company organized and existing under the laws of Hong Kong, located and doing business at Room 1713 & 1715, Leighton Centre, 77 Leighton Road, Causeway Bay, Hong Kong (hereinafter "CNSF") has commenced sales of fireworks bearing the Trademark in the United States subject to an exclusive licensing arrangement with Ciba wherein CNSF recognizes Ciba's ownership and right to register the Trademark in the United States and Ciba's right to own and prosecute the Application

WHEREAS, CNSF warrants and represents that its prior use of the Trademark in the United States inures to the benefit of Ciba, and that the goods sold, and the display and depiction of the Trademark thereon, were subject to Ciba's review and quality control.

WHEREAS, CNSF is desirous of acquiring an ownership interest in and to the Trademark in the United States and in and to the Application, as well as any U.S. registration that may result from the Application.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Ciba does hereby sell, assign and convey unto CNSF and Ciba as joint owners, all right, title, and interest in and to the Trademark for the United States and in and to the Application, including any resulting registration, together with the goodwill of the business appurtenant thereto in connection with which said Trademark is used and which is symbolized by said Trademark. As a result of said sale, assignment and conveyance, Ciba and CNSF will stand as joint owners of the Trademark in the United States, each with an undivided half interest therein, and will be joint owners of the Application, each with an undivided half interest therein, and of any registration ensuing therefrom in the United States.
