
DECLARATION OF GEORGE E. HAWRANKO
REGARDING CORRECTION OF
ERRONEOUS RECORDATION

I, George E. Hawranko, hereby declare as follows:

1. I am Senior Associate General Counsel of Electrolux North America, the North American Division of Aktiebolaget Electrolux.
2. Aktiebolaget Electrolux is the true and correct owner of Trademark Registration No. 686,520, for the mark ELECTROLUX (Stylized).
3. The assignment recorded at Reel/Frame No. 0620/0600 between Cardiff Publishing Company, Inc. and Cardiff Trademark Company contained erroneous information, and was recorded in error against Registration No. 686,520. Specifically, the assignment lists "Registration/Serial Number" 686,520 as one of the transferred marks. However, the assignment should have listed the Serial No. 73/686,520 as the number of the application being transferred between Cardiff Publishing Company, Inc. and Cardiff Trademark Company. The assignment was therefore recorded in error against Aktiebolaget Electrolux's Registration No. 686,520.
4. A summary of the correct chain of title showing Aktiebolaget Electrolux as the last listed owner is attached.
