RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST** ("Release") is given as of this 7th day of April, 2004 by Bank of America, N.A., a national banking association, ("Assignor"), located at 100 North Tryon Street, Bank of America Corporate Center, Charlotte, NC, 295255, in favor of New Orleans Saints, LLC, a Texas limited liability company ("Assignee"), located at 5800 Airline Drive, Metairie, LA, 70003.

WHEREAS, pursuant to a Security Agreement, dated as of November 15, 2000 (the "Security Agreement"), by and among New Orleans Louisiana Saints Limited Partnership, a Texas limited partnership, and Bank of America, as the collateral agent for the Purchasers, the Bank Investors, Kitty Hawk and the Bank Lenders (each as defined in the Security Agreement; together, the "Secured Parties"), New Orleans Louisiana Saints Limited Partnership granted to the Collateral Agent for the ratable benefit of the Secured Parties a continuing security interest in and to, and right of set off against, the trademarks and service marks, trademark and service mark registrations and applications shown on the attached Schedule A hereto (the "Trademarks"), which security interest was recorded in the United States Patent and Trademark Office on January 29, 2001 at Reel 2183/Frame 0431; and
