ASSIGNMENT OF TRADEMARKS

ASSIGNMENT, made as of April 11, 2002 from each of MEGGITT DEFENSE SYSTEMS [TEXAS], INC., a Texas corporation ("MDST"), and S-TEC CORPORATION, a Texas corporation ("S-TEC" and together with MDST sometimes referred to herein as the "Assignor"), to DRS AIR, INC., a Delaware corporation ("Assignee").

RECITALS

WHEREAS, pursuant to an Asset Purchase Agreement dated as of April 4, 2002 (the "Asset Purchase Agreement") among MDST, Meggitt-USA, Inc. and Assignee, MDST has agreed to sell, assign, transfer, convey and deliver to Assignee all of its right, title and interest in and to the Acquired Assets (as defined in the Asset Purchase Agreement);

WHEREAS, in consideration for MDST's sale, assignment, transfer, conveyance and delivery to Assignee of the Acquired Assets in accordance with the terms and conditions of the Asset Purchase Agreement, Assignee shall pay to MDST the Purchase Price (as defined in the Asset Purchase Agreement);

WHEREAS, Assignor is the sole owner of the entire right, title and interest in, to and under the service marks, trademarks and trademark applications identified in Schedule A attached hereto and used in the Business (the "Trademarks"), and has a registration for, or has filed an application to register, the Trademarks in the United States Patent and Trademark Office and the other foreign jurisdictions set forth on Schedule A; and

WHEREAS, in connection with Assignee's acquisition of the Acquired Assets, Assignee desires to acquire, and Assignor is willing to convey, Assignor's entire right, title and interest in, to and under the Trademarks, all goodwill associated therewith, and all common law rights therein.

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee Assignor's entire right, title and interest in, to and under the Trademarks, including common law rights, together with the goodwill symbolized by and associated with the Trademarks, and all registrations and applications relating to the Trademarks, for its own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all income, royalties, fees and payments now or hereafter due or payable in respect of the

Trademarks, and the right to file any action and recover damages by reason of past infringement, misappropriation or other unauthorized use of said Trademarks, with the right to sue for, and collect same for its own use and behalf, and for the use and behalf of its successors, assigns, or other legal representatives.

Assignor hereby agrees to execute, acknowledge and deliver to Assignee all documents, instruments and agreements as may be necessary to make a record with any Governmental Authorities (both foreign and domestic) or third parties of Assignee's ownership of all right, title and interest in, to and under the Trademarks and the goodwill associated therewith.


S-TEC hereby represents and warrants that it is the sole owner of the Trademarks free and clear of all Liens.

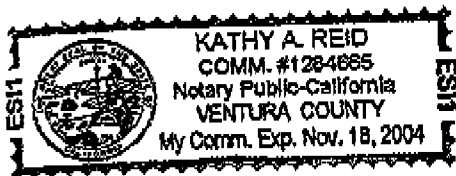

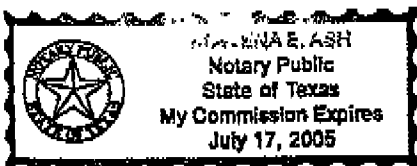
