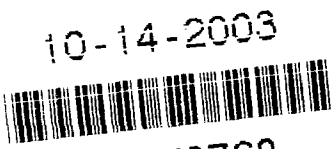

RELEASE OF SECURITY INTEREST AND LIENS IN TRADEMARKS

WHEREAS, Reddy Ice IP, Inc. 2. This release of security interest and liens is being executed by the Secured Party, for itself and for the Lenders, with the intention that it be recorded in the U.S. Patent and Trademark Office to evidence that none of the properties listed on Schedule 1A hereto are subject to the security interest and liens as set forth in the Agreement.
