TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 30, 2003, by **HELLER FINANCIAL, INC.**, as Agent, a Delaware corporation ("Agent").

WITNESSETH:

WHEREAS, Agent and McKenzie Sports Products, Inc., a North Carolina corporation ("**Borrower**"), were parties to that certain Trademark Security Agreement dated as of October 26, 1999 (the "**Agreement**"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Agreement), pursuant to which the Borrower granted a security interest to Agent in, among other things, the Trademarks (as defined in the Agreement) as security for certain obligations owing by Borrower to the financial institutions (collectively, the "**Lenders**") from time to time party to that certain Credit Agreement dated as of October 26, 1999, as amended and restated by that certain Amended and Restated Credit Agreement dated as of September 29, 2000, by and among Borrower, Agent, and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Trademarks set forth on Schedule 1 annexed hereto; and

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on **November 1, 1999, at Reel 1983, Frame 0322**; and

WHEREAS, Borrower has requested that Agent release its security interest in the Trademarks and reassign the same to Borrower;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Borrower's right, title and interest in and to all of the following:

(a) each Trademark, Trademark registration and Trademark application together with any reissues, extensions or renewals thereof, including, without limitation, the Trademarks, Trademark registrations and Trademark applications referred to in Schedule 1 annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, Trademark registration and Trademark application;

(b) each Trademark license and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark license; and


