TRADEMARK ASSIGNMENT

Moreover, Assignor assigns the right to bring suit and collect for infringements thereof, the foregoing to be held and enjoyed forever by Assignee for its own use and benefit and for the use and benefit of its successors and assigns as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor covenants that it is the owner of the Marks and the holder of record title to the registrations and applications for registration therefore.

Assignor agrees to assist Assignee in every way (but at Assignee's expense) to obtain, and if so requested by Assignee, to apply directly for and obtain, in the name and on behalf of Assignee, trademark and other statutory or common law protection for such Marks in any and all countries and to execute any and all papers concerning such Marks that may be considered necessary or helpful by Assignee (i) to apply for and to obtain such trademark and other statutory or common law protections therefor, to enforce the same, and (ii) to effect the assignment and transfer of all title, right, ownership and interest in and to such Marks and the registrations and applications for registration thereof and all rights therein to Assignee or to its successors and assigns.
