Dear Trademark Office:

If you look at the assignment history for this trademark, the outside attorneys did the assigning wrong and this is just to correct it. The trademark was in GoodHome, Inc. (now known as Scene7, Inc., it is the same company we just changed names).

If you look at your file, the outside attorneys, at Assignment 9, mistakenly assigned this "from" GoodHome LLC (a holding company, that did not have the trademark in it to begin with, as you can see from Assignment 8) "to" Rhodes Partners (who were taking a security interest because they were financing GoodHome/Scene7). When the security interest was then "released" it was "released back" to GoodHome LLC – where the trademark should never have been, and never was before. This Assignment is merely to get the trademark back where it belongs and where it was at Assignment 8 – in GoodHome Inc (now known as Scene7, Inc).
